PARTICIPATION CONTRACT

1. SUBJECT OF THE CONTRACT

The present Contract regulates the relations between SIBICO International Ltd. (hereinafter referred to as "SIBICO " or "Secretariat") and Company (hereinafter referred to as "Company") on preparation and participation of Company's representative (hereinafter referred to as "Participant") in 26th International NO-DIG 2008 Moscow Conference (hereinafter referred to as "Event"). The present Contract is drawn in form of a public offer.

3. OBLIGATIONS OF THE PARTIES

3.1. SIBICO: Conducts all the preparation work on organizing and holding the Event, including: concept development, technical programme finalising, invitation of key-speakers, promotion in mass-media, publishing of the conference materials, registration of the Participant and organisation of his work in the conference, composition of a "delegate wallet", transfer for the Participant from the nearest metro station to the venue, soft drinks and coffee-breaks.

26th International NO-DIG 2008 Moscow Conference registration fee covers: participation in the conference, admittance to the exhibitions, a "delegate wallet", a CD-ROM with full texts of presentations (in English) and abstracts of the presentations (in Russian) included in the program for oral presentation, an exhibition No-Dig catalogue, metro station - exhibition center - metro station transfer, simultaneous translation, two daily coffee breaks (3-5 June), evening reception and two field visits (to be confirmed).

3.2. Company:

3.2.2. Submits the originals of the present contract and services acceptance certificate.

4. REGISTRATION AND PAYMENT FOR PARTICIPATION

4.1 To participate in the Conference you should fill in the registration form: tick where appropriate; fill in your company's details (including bank account details) and representative's details. 4.3. Full payment for participation should be done prior to the Event, otherwise the Participant cannot be registered.

5. CANCELLATION OF REGISTRATION

Cancellations, in writing, received before 1 March 2007, are 90% less the bank charges refundable. Cancellations, in writing, received between 1 March and 1 April 2007, are 60% less the bank charges refundable. Cancellations, in writing, received between 1 April and 1 May 2007, are 30% less the bank charges refundable. No refunds can be done after 1 May 2008.

6. SPECIAL CONDITIONS

6.1. By signing the present Contract the Parties accept its conditions, rules, regulations and prices, stated in the present Contract.

6.2. Terms of the present Contract can be modified or supplemented by mutual agreement of the Parties. The modifications and supplements for the present Contract are drawn up by signing the additional agreements.

6.3. The last day of the Event is the date of the performance of service. The Company should sign the services acceptance certificate or send a well-grounded refusal within 30 days after receiving by the Participant the copy of the certificate or within 30 days after sending it by mail to the Company. The service is considered accepted by the Company in case of non-return of the said certificate or non-sending a written refusal to sign the services acceptance certificate within this period.

6.4. The present Registration form should be submitted to SIBICO prior to the Event.

6.5. Any litigation that may arise during the fulfillment of the present Contract and that cannot be settled by the Parties' consent will be settled by arbitration according to the Law of the Russian Federation.

6.6. The present Registration form becomes effective when it is signed and stays effective till 30 June 2008.
